Re: Annual Report on Eviction Notices

Dear Ms. Young:

Pursuant to Section 37.6(j) of the Rent Ordinance, Chapter 37 of the San Francisco Administrative Code, the Rent Board is providing its annual report on the number of eviction notices filed with the department. During the period from March 1999 through February 2000, a total of 2,641 various evictions notices were filed with the department. This figure includes 171 notices given due to failure to pay rent, which are not required to be filed with the department. The number of notices filed with the department this year represents a nine percent decrease over the prior year's filings.

The list on the following page gives the total number of notices filed with the department, stated reason for the eviction and the applicable Ordinance section.

As a matter of comparison, last year (1998/99) there were 2,878 notices filed with the department and for 1997/98, a total 2,726 notices filed. Those just cause reasons experiencing the greatest fluctuation since last year are as follows:
